The Sumitomo Group Companies —Carrying On a Business Spirit Cultivated through 400 Years—

The various business endeavors that led to the Sumitomo Group companies of today were born in tandem with modernization of the Besshi Copper Mine. Charcoal and mine timber operations gave rise to forestry business; civil engineering operations, to the construction business; and repair and manufacturing operations, to the machine industry. The chemicals industry was launched to solve smoke pollution problems. In Osaka, operations expanded into a copper rolling industry, and related technology expanded to operations in wiring and metals. The Group also became involved in the development of Osaka port and came to play an important role in land development and construction operations. Currency exchange business, which began in the Edo period, led to the establishment of a bank and warehouses funded by the earnings from Besshi; followed by expansion into insurance, trust banking and other financial areas. In the 20th century, technological innovations worldwide led to engagement in new operations including telecommunications, sheet glass and synthetic resins.






